League Rules

- (1) Determine home team by coin flip before game.
- (2) No strike outs, no walks. But please, please, please put the ball in play.
- (3) Co-ed teams encouraged, but not required.
- (4) Players can be taken out of games and put back in at any time.
- (5) Teams can bat a 10-man line-up or an “all players available” line up. Either way, batters must bat in the order set at the beginning of the game.
- (6) Safe/out calls will be made in good faith. If there is a disputed call, the base coach nearest to the play will have the final word and must make the decision in good faith. If the base coach wasn't paying attention to the play, the call will be made by the nearest fielder not involved in the play and must be made in good faith.
- (7) No stealing bases or leading off. Runners can begin advancing on the swing.
- (8) Normal infield fly rule applies -- *i.e.*, batter is automatically out when he/she hits a fly ball in fair territory that is reasonably catchable by an infielder with runners on first and second base or the bases loaded with less than two outs in the inning.

Play-Offs

After each game, the team captains should email the final score to Todd Cook (tjc@stevenslee.com) who will keep the official league standings as reported each week by the team captains.

Top four teams in standings advance to the play offs.

If there is a tie in the standings, the winner of the two teams' regular season head-to-head match up is the tie breaker.

Pre-Season

Teams are free to schedule pre-season games that will not count in the official league standings.
